Dear Speaker Hastert:

On behalf of the undersigned national and state medical societies, we urge you to pass legislation during the lame-duck session of Congress to halt a scheduled across-the-board cut in Medicare payments to physicians and provide physicians with a positive payment update for 2007. If Congress does not act, the sustainable growth rate (SGR) will cut Medicare payments to all physicians by 5 percent on January 1, 2007. On numerous occasions, Members of Congress have indicated that this pending cut would be addressed prior to the end of the 109th Congress. We stand ready to work with you to fulfill those commitments.

In addition to the SGR cuts, many physicians will see cuts from other Medicare changes as well. In fact, nearly half are facing combined cuts of 6 to 20 percent due to the following policies: expiring geographic adjustments, imaging cuts mandated by the Deficit Reduction Act of 2005, budget neutrality adjustments associated with the five-year review, and changes in the practice expense methodology. These policies will compound the effect of SGR cuts for thousands of physicians and make it even more imperative that Congress act now to stop the SGR cut before it destabilizes the Medicare program and erodes access to care for America's seniors.

According to an American Medical Association survey, if payments are cut as projected in 2007, 45 percent of physicians will either decrease or stop accepting new Medicare patients in 2007, and 50 percent of physicians plan to defer the purchase of information technology. Additionally, 43 percent of physicians will decrease the number of new TRICARE patients they accept, as TRICARE ties its physician payment rates to Medicare.

Stopping the SGR cut is the action that Congress should take to improve the outlook for all Medicare physicians and their senior patients. **Over 265 members of the U.S. House of Representatives and over 80 members of the United States Senate have signed letters this year urging that physicians be provided with a positive payment update in 2007.**

We strongly urge Congress to take immediate action to fulfill the commitment it has made to America's seniors to ensure their continued access to high quality health care.
